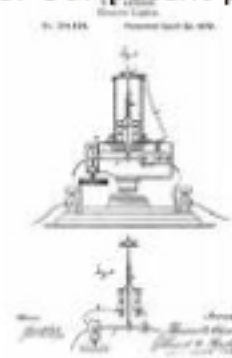

2. Name of the article.
3. Description of Goods
4. Photographs / drawings of article showing different poses from all Angles with six copies of each pose.
5. View of the article from all sides.
6. Particulars of priority application, if any.
7. Material predominant in the article (e.g. plastic, metal, wood etc.)
8. List of countries to claim the priority, if any, where the application / applications for Design has / have been filed alongwith application number and date.
9. Power of attorney.

Copyrights



Registration of copyright is optional but a registered owner has exclusive right to reproduce or publish his work in a material form. These monopoly rights are vested in to the registered owner for life time until 60 years from the beginning of the calender year next following the year in which the work is first published. The subject matter of copyright is original literary, musical, dramatic and artistic work, cinematographic films and computer programmes. We provide following services relating to copyright registration in India:

Requirements for filing

1. Full name, address and nationality of applicant(s) and author(s)
2. Four copies of the work
3. Title, Language and brief description of the work
4. A document supporting the right of the applicant in the work
5. If the work is published, year and place of first publication; name, address and nationality of the publisher; years and place(s) of subsequent publications if any, as well as names, addresses and nationalities of the publisher(s).
6. Names, addresses and nationalities of the owners of the various rights comprising the copyright in the work and the extent of rights held by each, together with the particulars of assignments and licenses, if any.
7. Power of attorney.
